## Child Abuse as Defined in Washington State

RCW 26.44.020 (1)

defines abuse and neglect as injury, sexual abuse, sexual exploitation, negligent treatment or maltreatment of a child under circumstances which indicate that the child's health, welfare, and/or safety is harmed. Physical discipline of a child is not considered abuse as long as it is reasonable and moderate as defined in RCW 9A 16 100

Any use of force on a child by any persons other than the child's parent, guardian, or teacher is unlawful unless it is reasonable and moderate and is authorized in advance by the child's parent, or guardian.

# FAQ Frequently Asked Questions

#### Can Anyone refer to the CAC?

No, it is important that Law Enforcement and/or CPS are the lead in making a referral. If you suspect that a child is being abused please contact Law enforcement or DCYFS.

### Does it cost to use the CAC Services?

No. Family Crisis Network CAC is a grant and donation funded agency. The services provided are free of charge.

### What are the ages of children served at the CAC?

Generally ages 3-17 but referrals are a case by case basis depending on developmental capacity and verbal capacity of the child.

## Do you work with children even if the case is not prosecuted?

Yes. The child Advocacy Center is all about helping child victims and their non-offending family members receive comprehensive services. Referrals, support, and therapy are available regardless of the status of the case.
